Attention Health Information Managers and CMI Coordinators:

Please be advised that a number of codeset changes are being made on the CMI/ODS to meet a number of business requirements including the following:

- Amendments to 'Reason for Restraint' and 'Reason for Seclusion' to comply with the *Mental Health Act 2014*;
- Inclusion of Consumer and Carer workers in list of Health Care Practitioner Disciplines; and
- The implementation of Transition Support Units.

These changes have been made in the ODS and are available to be downloaded to CMI's.

Purpose of Bulletin

This Bulletin summarises the changes which are being made and provides clarification regarding new or amended business rules.

CMI/ODS Codeset Changes – December 2015

Additions to program type and discipline codesets

Additions are being made to the program type and discipline codesets, the reasons and details are as follows:

1. Carer and Consumer Workers

Recent service system developments have increased reliance on the peer and carer workforce. However, the current discipline codes on the CMI/ODS do not have sufficient fidelity to capture the increasing volume of service activity being delivered by these groups.

2. Transition Support Units

The Mental Health and Drugs Branch have committed to funding the development of Transition Support Units in a number of locations in metropolitan Melbourne. These units have funded targets in the Victorian Policy and Funding Guidelines for 2015-16. Expanding the program type codeset to include Transition Support Unit's allows them to be uniquely identified within the CMI/ODS.

3. Other gaps in the Program Type codeset

Previously the Program type codes for Community, Primary Mental Health Team; Community, Dual Diagnosis and Community, Peri-Natal Emotional Health did not provide options to adequately describe the target population. Additions to the codeset are being made so that this information can be adequately described.

Updates to Reasons for Restraint and Seclusion codesets

Prior to these updates the codes in CMI/ODS for 'Reason for Restraint' and 'Reason for Seclusion' were aligned with the Mental Health Act 1986. However the collection/authority form MHA 140 'Authority for use of restrictive interventions' is aligned with the Mental Health Act 2014, as is required to meet legislative obligations. As a result there will be updates to the current CMI/ODS codes for 'Reason for Restraint' and 'Reason for Seclusion' such that they align with the requirements of the Mental Health Act 2014 and what is collected on the Mental Health Act Form 140 'Authority for use of restrictive interventions'.

The changes being made are outlined below.
