High Risk Patients

Patients at risk of representing or having ongoing concerns

ED Care Co-ordination Team follow these Patients up with **Follow Up Phone Calls**

Previous days discharged pts that meet the ED's criteria of "high risk" are phoned. All DNW pts with no clear plan from triage are phoned to provide opportunity for improved customer service and quality care review



Patients presenting with:

- Falls
- Abdominal pain
- Chest pain
- Back pain (>50 years)
- Asthma (<14 years)
- Febrile (<3 years)
- Retention of urine
- Soft tissue injuries (<10 years & >65 years)
- Did Not Wait to be seen by a Clinician





When reviewing these patients the following is taken into account:

- Location
- Next of kin supports
- Local Doctor
- Nationality
- Reason for presentation
- Medical plan
- Number of presentations to EH





Outcomes

- Patient current status advice provided
- Links to services and referrals
- Any concerns discussed with a Clinician
- Feedback +/- is provided to the Nurse Unit Manager who is able to pass this onto staff at the staff meeting (minutes taken for all staff to access)
